## **Campus CERT Team**

New River Community College is participating in a new program through the Virginia Department of Emergency Management and Virginia Citizens Corps - the Campus CERT *Team Initiative*. CERTs – or Community Emergency Response Teams – gained popularity after 9/11 as an effective means for mobilizing resources within communities as small as a single street or as large as a town. The new initiative aims at equipping college and university campuses with volunteers trained to perform specific tasks during an emergency.

In early November, NRCC's Emergency Coordination Officer (ECO), Amy Hall, and Alternate ECO, Tony Nicolo, will participate in a three-day Campus CERT Team Trainthe-Trainer workshop. Subsequently, the college will put together a training program and solicit volunteers. Some of you have already volunteered! (Thank you.) Please consider what role, if any, you might want to play in this new effort.

### **Cell Phones in Class?**

The classroom policies seem to run the gamut. Many faculty ban cell phones – or at least the sight and sound of cell phones -- in their classrooms. Others don't seem to mind either way, and still others are finding ways to make use of the devices in the context of teaching and learning.

Regardless of where you stand on the issue, please consider the benefits of having your own cell phone with you in the classroom. Should an emergency occur that takes out the college's phone system, or in some way prevents you from getting to the handset in the classroom, your cell phone may be the only means you have of contacting Security or dialing 911.
